

# Chairman's Statement

The Board is pleased to report that the year to 29 February 2012 has seen positive progress in Shareholder returns, with further expansion of the portfolio and a continued focus on making later-stage, income producing private company investments. This strong performance has been achieved against a background of persistent economic uncertainty and a challenging trading environment for the UK smaller company sector.

The key objective for your Company is to generate long-term capital growth and maintainable levels of tax-free income, by investing only in mature cash generative private companies, on prudent entry multiples. This investment approach has allowed your Company to build a widely diversified portfolio and deliver growth in NAV for Shareholders, while paying an increasing level of tax-free dividends.

Overall your Board is encouraged by the progress being made by your Company, which validates the investment strategy, and has noted recent market analysis which reflects the success of that approach. The Manager's ability to identify high growth private company assets was highlighted in the Deloitte Buyout Track 100 report in February 2012. Four of your Company's existing portfolio investments feature in this report, which tracks the performance of the top 100 private equity backed medium-sized companies in Britain over the past two years.

#### The highlights of the year under review are:

- NAV total return of 112.0p per share (2011: 104.4p) at year end, up 7.3%;
- NAV of 67.9p per share (2011: 65.3p);
- five new later-stage high yielding private company investments completed, with two further holdings acquired after the period end;
- disposal of Walker Technical Resources for a total return of 3.0 times original investment cost, with two further profitable exits completed after the period end; and
- a final dividend proposed of 3.5p per share, comprising 0.5p revenue and 3.0p capital, to make a total of 5.0p for the year.

#### Performance

The NAV total return per share at 29 February 2012 was 112.0p, an increase of 7.3% over the equivalent figure at 28 February 2011. The most important measure of performance for a VCT is the NAV total return, being the long-term record of dividend payments out of income and capital gains combined with the current NAV. In the short term, the NAV in isolation is a less important measure of performance as the underlying investments are long-term in nature and not readily realisable. At 29 February 2012, the NAV per Ordinary Share was 67.9p.

## VCT qualifying status

The Company is required to meet the VCT qualifying criteria on a continuous basis. The Board regularly reviews the status of these criteria and is pleased to confirm that all tests have continued to be met.

#### Dividends

The Board is proposing a final dividend of 3.5p per share, comprising 0.5p of revenue and 3.0p of capital, to be paid on 20 July 2012 to Shareholders on the register at close of business on 22 June 2012. Including the interim dividend of 1.5p per share paid in December 2011, the total tax-free yield is 8.7% based on the share price of 57.25p at the year end, which is equivalent to 11.6% on a taxable UK equity investment for a 40% tax payer. The effect of paying the proposed final dividend of 3.5p will be to reduce the NAV per Ordinary Share to 64.4p.

## Investment strategy

Your Company's strategy is to invest in a broadly based portfolio of income producing later-stage UK private companies across a range of industry sectors, while also looking to achieve significant regional diversification.

The Manager has a nationwide office network, with six regionally based teams which are introduced to a wide range of prospective private company transactions each year. Each potential investment is carefully scrutinised and subject to strict selection criteria. New investments will only be made where businesses are available at conservative entry prices, in transactions typically structured with a significant element of secured loan stock in order to generate an immediate high yield.

The structured exit from the AIM/PLUS portfolio has also continued during the year, with a number of further disposals made to realise cash to fund the expansion of the private company portfolio. The Board and the Manager take the view that the potential returns available from AIM and PLUS quoted investments remain too uncertain at the current time and, at the period end, these represented less than 2% of the portfolio by value.

The Listing Rules require your Board to ensure that this Report includes information on the investment policy, including a description of the asset mix, the spread of risk and maximum exposures. This information is contained in the Directors' Report and in the various tabular analyses of the portfolio.

#### Principal risks and uncertainties

The Board has reviewed the principal risks and uncertainties facing the Company for the financial year. In order to minimise the exposure to investment risk, the Company has invested in a broadly-based portfolio of holdings in private and AIM or PLUS quoted companies in the UK.

## Valuation process

Investments held by Maven Income and Growth VCT in unquoted companies are valued in accordance with the International Private Equity And Venture Capital Valuation Guidelines.

Investments quoted or traded on a recognised stock exchange, including the Alternative Investment Market (AIM), are valued at their bid prices.

#### Portfolio developments

During the year there were five new and eight follow-on investments completed, and the Manager has also invested in two new private companies since the year end. In line with the strategy of investing only in established cash-generative businesses, each of the new assets has little or no bank or other external debt and is forecast to generate substantial levels of income from the outset. The private equity portfolio is generally performing well, with most companies trading at or ahead of plan. The increasing maturity of a number of holdings is also leading to the emergence of M&A interest in several existing portfolio companies, and the Manager is currently working on a number of potential exits, although there can be no certainty that these will ultimately lead to profitable disposals.

Details of investments and realisations during the year are shown in the Investment Manager's Review on pages 10 to 14 and the Board is pleased to report that there have been three profitable private company exits for the Company, including two after the year end. The realisation of Walker Technical Resources in July 2011 achieved a 3.0 times total return on the initial investment cost, whilst the exit from ATR Group in March 2012 realised a return of 1.7 times investment cost. More significantly, the disposal of the holding in TPL (Midlands) Limited (trading as Transys Projects) was completed in early June 2012. For contractual reasons the Directors are not able to publish specific details of the transaction, which has not been reflected in the Financial Statements for the year ended 29 February 2012. However, as a result, there will be an increase of approximately 4.7p per share in the net asset value of the Company, representing an uplift of 6.9% on the year-end figure.

#### Share buy-backs

The Company has bought back a total of 495,000 shares for cancellation throughout the year. Buying these shares in the market created some liquidity and the discount had narrowed to 15.7% at the year end. At the forthcoming AGM, the Company will again seek the authority of Shareholders to continue to buy back shares in the market.

## Recovery of VAT

The Board has continued its dialogue with Aberdeen Asset Management PLC (Aberdeen) with a view to making further recovery of VAT paid previously by the Company in respect of investment management fees. An offer of £118,425 in respect of VAT paid during the period from 28 June 2004 to 30 September 2005, plus interest of £18,585, was received and accepted as final settlement on the basis that the Company will remain entitled to any additional VAT and interest recovered from HMRC by Aberdeen. The receipt of these amounts has been reflected in the Financial Statements.

### Co-investment scheme of the Manager

The co-investment scheme, which allows executive members of the Manager to invest alongside the Company, continued in operation during the year. The scheme operates through a nominee company which participates in every transaction completed by the Company, including any follow-on investments. The scheme closely aligns the interests of the executives and the Company's Shareholders, while providing an incentive to enable the Manager to retain the existing skills and capacity of the investment team in what is a competitive market for talent.

#### Share capital and fund raising

In the period to 3 May 2011 your Company raised additional funds through a linked VCT Top-up Offer with Maven Income and Growth VCT 2, Maven Income and Growth VCT 3 and Maven Income and Growth VCT 4. Net proceeds of £912,000 were raised, after deduction of costs, and 1,511,929 new shares were issued.

In December 2011 your Board announced a further Top-up Offer for Subscription, in parallel with similar Offers by Maven Income and Growth VCT 2, Maven Income and Growth VCT 3 and Maven Income and Growth VCT 4, with each Company aiming to raise £1.25 million before expenses (this amount being within the maximum permitted under the Prospectus Rules and avoiding the Company having to incur the higher costs associated with publishing a full prospectus). I am pleased to report that the Offer was oversubscribed and closed early on 1 March 2012, which in the view of the Board is a positive reflection of the Manager's generalist strategy that has produced improved Shareholder returns in recent years.

The monies raised under such Offers may be used by the Company to pay dividends and cover general running costs, which has the advantage of preserving for investment purposes an equivalent sum of valuable 'old money' which operates under more flexible VCT regulations. The proceeds will also provide additional liquidity for the Company to make more later-stage investments, and allow it to spread its costs over a larger asset base to the benefit of all Shareholders.

#### Outlook

The Company is well placed to continue to achieve attractive long-term tax-efficient returns, by deploying capital in sensibly priced mature private company assets capable of delivering long-term capital appreciation. The private company portfolio continues to generate strong revenues for your Company in support of a sustainable dividend programme, and your Board believes that the later-stage investment strategy employed by the Manager will produce ongoing improvements in Shareholder returns.





# Investment Manager's Review

#### Overview

The prospects for the UK economy remain uncertain, with renewed concern over the threat to Britain's AAA credit rating following the declaration by Moody's of a "negative outlook" over weaker growth prospects and the potential effect of the eurozone crisis. This view is consistent with the Government's 2011 Autumn Statement which forecast that the public sector borrowing requirement will increase over the next five years, and that an extended period of spending restraint will be required in order to ensure that the UK maintains its current rating. This fiscal control and lower discretionary spend capacity is likely to impact on both consumer and investor confidence over the medium term.

Notwithstanding the challenging economic environment, we are encouraged to note that the majority of private companies in the portfolio are trading in line with expectations. Investments are made only at sensible entry prices in businesses with little or no external debt, in transactions structured with a significant element of loan stock in order to provide a high yield to the VCT from the outset. This helps to create value for investors through a combination of revenue generation to fund dividends and the potential for capital growth at exit. This approach is now delivering tangible results, including consistent improvements in NAV and dividend levels in recent years, and will continue to be the cornerstone of our investment strategy.

There remains a steady flow of new transactions and investment opportunities in our target private equity market, and we have been able to leverage our national presence and local advisory relationships to generate over 400 private company introductions around the UK in the past 12 months.

#### Investment activity

During the year under review, the Maven team completed five substantial new private equity investments on behalf of your Company, alongside eight follow-on investments in existing portfolio companies. There was one private company disposal during the year and one exit completed shortly after the year end.

At 29 February 2012, the portfolio stood at 56 unlisted and AIM/PLUS investments at a total cost of £24.4 million and a further two new private company investments have been added to the portfolio since the year end.

Maven Income and Growth VCT has co-invested in some or all of the above transactions with Maven Income and Growth VCT 2, Maven Income and Growth VCT 3, Maven Income and Growth VCT 4, Maven Income and Growth VCT 5, Talisman First Venture Capital Trust and Ortus VCT. The Company is expected to continue to co-invest with these as well as other Maven clients, which offers the advantage that, in aggregate, they are able to underwrite a wider range and larger size of transaction than would be the case on a stand-alone basis.

#### Portfolio developments

The five new private company investments added to the portfolio during the period under review were:

- Glacier Energy Services Group, a profitable oil & gas service group with two specialist trading subsidiaries, Roberts Pipeline
  Machining and Wellclad. Roberts designs and manufactures on-site portable cutting machines for blue chip oil & gas clients.
  Wellclad provides services to the European offshore and sub-sea equipment market. Glacier is focused on growth within its core
  UK market as well as promoting its technologies to the international oil & gas market;
- Space Student Living, a business providing contracted property management services across the student housing sector. Space
  aims to achieve significant growth across its consultancy services operation, in tandem with the acquisition of further long-term
  management contracts;
- Maven Co-invest Exodus, a new company trading as 6° Group, established by Penta Capital to implement a buy-and-build strategy in the business telecommunications service sector based on the converging of mobile, fixed-line, broadband, internet and IT technology businesses. Penta is an established private equity firm with which Maven previously co-invested in the successful 2010 management buy-out of esure;
- LCL Hose, trading as Dantec, a specialist manufacturer of hand-built composite hoses for the global petro-chemical industry.
   Composite hoses provide the vital flexible connection in many fluid transfer systems, and are used worldwide in applications such as uploading road, rail and marine tankers within chemical and oil plants, and in Formula 1 racing. Dantec exports around 70% of its output and is engaged in a number of significant overseas projects; and
- Moriond, a new company set up to acquire an established residential property portfolio at a significant discount to open market
  value. Maven will work on a joint venture basis with an experienced developer to break up the portfolio into single units, carry
  out minor refurbishment, and then implement a structured sale of the individual assets over an 18 to 24 month period. The
  transaction is projected to generate a significant capital gain alongside a 6.5% paid yield through the life of the investment.

The two further private company investments which have been added to the portfolio since the year are:

- Vodat International, a provider of payment and communications solutions to high street businesses, which enable retailers to
  reduce costs, boost store productivity and increase sales in an increasingly competitive trading environment. The company
  has an established and diverse customer base, has consistently improved profitability in recent years and enjoys high levels of
  recurring revenue from a number of long-term service and support contracts; and
- Cat Tech International, a niche industrial services business offering catalyst handling products and services to petro-chemical plants operating in the major international markets. The business specialises in servicing equipment used in applications where operational efficiency is critical and there is an increasing global focus on health and safety issues, and has developed a range of patented products and processes to improve the efficiency, speed and safety of catalyst operations.

There was one notable private company exit during the period, with the holding in Dalglen 1150 (Walker Technical Resources) being realised in July 2011 and further proceeds received on agreement of completion accounts. Total proceeds over the life of the investment were £1,591,000 and represented an overall return of 3.0 times the initial cost. The exit was via a secondary buy-out, funded by Gresham Private Equity, just two years after Maven originally led the management buy-in in June 2009. Walker, which provides some of the most advanced composite repairs technology available for the global oil & gas industry, has consistently traded ahead of budget and more than doubled earnings since our initial investment.

In March 2012, Maven completed the realisation of ATR Group for £19.25 million via a secondary buy-out funded by the private equity manager NBGI, realising a return of 1.7 times the initial cost and proceeds of £530,000 for the Company. ATR provides rental services for specialist plant, equipment and consumables, along with a comprehensive range of added value support services, to offshore and onshore energy services maintenance contractors operating in highly regulated environments. More recently, in early June 2012, the Manager completed the sale of TPL (Midlands) Limited (trading as Transys Projects), a business that provides turnkey and engineering consulting solutions relating to the maintenance and enhancement of rail rolling stock, to the German engineering group Vossloh Kiepe (part of MDAX listed Vossloh AG), a specialist provider of control systems and electronic equipment for rail vehicles and industrial plant. The acquisition will allow the combined business to enter into new markets and bid for larger rail enhancement projects.

Maven is also currently engaged with several other investee companies and prospective acquirers regarding possible exits from those holdings. This potential realisation activity is encouraging and reflects the increasing maturity of the private company portfolio although, of course, there can be no certainty that these discussions will ultimately lead to profitable disposals.

Two unlisted investments and one AIM quoted company were struck off the Register during the year resulting in realised losses of £1,080,000 and £700,000 respectively. However, these had no effect on the Company's NAV as full provisions against the cost of these investments had been taken in previous years.

In respect of AIM quoted holdings, the Manager has continued its policy of structured exits from this part of the portfolio.

#### Outlook

Maven has one of the most highly resourced and experienced management teams in the VCT industry, and its regional model provides access to a large number of interesting private company transactions each year. The continuing scarcity of bank debt also means that an increasing number of private companies are seeking capital from generalist VCT managers, and these favourable market conditions should ensure that your Company is well placed to continue to deliver positive returns to Shareholders in the years ahead.

# Directors' Report

The Directors submit their Annual Report together with the Financial Statements of the Company for the year ended 29 February 2012.

#### Results and dividends

The NAV per share at 29 February 2012 was 67.9p (2011: 65.3p). The NAV per share has been calculated using the number of shares in issue at 29 February 2012 of 39,265,962 (2011: 38,249,033).

For the year ended 29 February 2012, the revenue profit on ordinary activities after taxation amounted to £868,000 (2011: £351,000). The total gain on ordinary activities after taxation for the year was £3,010,000 (2011: £2,659,000). During the year, an amount of £1,982,000 (2011: £1,519,000) was recognised in respect of distributions made to Equity Shareholders. The Directors recommend a final dividend for the year ended 29 February 2012 of 3.5p per share (2011: 3.5p), comprising 3.0p of capital and 0.5p of revenue, payable on 20 July 2012 to Shareholders on the register at close of business on 22 June 2012 and a Resolution to this effect will be proposed at the Annual General Meeting.

#### Business review

A full review of the Company's activities is given in the Chairman's Statement and in the Investment Manager's Review. In addition, this Directors' Report includes a summary of the business objectives, the Board's strategy for achieving them, the key performance indicators and the principal risks and uncertainties faced by the Company.

#### Investment objective

The Company aims to achieve long term capital appreciation and generate maintainable levels of income for Shareholders.

#### Statement of investment policy

The Company intends to achieve its objective by:

- investing the majority of its funds in a diversified portfolio of shares and securities of smaller, unquoted UK companies and in AIM/PLUS companies which meet the criteria for VCT qualifying investments and have strong growth potential;
- investing in line with VCT regulations, no more than £1 million in any company in one year and no more than 15% of the Company's assets by cost in one business at any time;
- maintaining a qualifying investment level of at least 70% according to VCT regulations;
- borrowing up to 10% of NAV, on a selective basis, in pursuit of its investment strategy; and
- retaining the services of a Manager that can provide the breadth and depth of resources required to achieve the investment objective.

The Company manages and minimises investment risk by:

- diversifying across a large number of companies;
- diversifying across a range of economic sectors;
- actively and closely monitoring the progress of investee companies;
- seeking to appoint a non-executive director to the board of each private investee company, provided from the Manager's investment management team or from its pool of experienced independent directors;
- co-investing with other funds run by the Manager in larger deals, which tend to carry less risk;
- not investing in hostile public to private transactions; and
- retaining the services of a Manager that can provide the breadth and depth of resources required to meet the criteria stated above.

Other risks are managed as follows:

- VCT qualifying status is monitored continuously and risk is minimised by retaining the services of a Manager that has the resources
  to provide sufficient flow of investment opportunities and integrated administrative and management systems to ensure continuing
  compliance with regulations; and
- risks of political change, exchange controls, taxation or other regulations that might affect investee companies, are monitored and taken account of before investments are made and when determining the valuations of unlisted investments.

### Statement of compliance with investment policy

The Company is adhering to its stated investment policy and managing the risks arising from it, and this can be seen in various tables and charts throughout the Annual Report, from figures provided in the Chairman's Statement and the Investment Manager's Review.

The management of the investment portfolio has been delegated to Maven Capital Partners UK LLP (the Manager), which also provides company secretarial, administrative and financial management services to the Company. The Board is satisfied with the depth and breadth of the Manager's resources and its network of offices, which supply new deals and enable it to monitor the geographically widespread portfolio companies effectively.

The Investment Portfolio Summary shows the number of investments in the portfolio and the degree of co-investment with other clients of the Manager. The tabular analyses of unlisted and AIM/PLUS portfolio by industrial sector and deal type show that the portfolio is diversified across a variety of sectors and deal types. The level of qualifying investments is monitored by the Manager on a daily basis and reported to the Board quarterly.

## Key performance indicators

At each Board Meeting, the Directors consider a number of performance measures to assess the Company's success in achieving its objectives. The key performance indicators are as follows:

- NAV total return; and
- dividends per share.

The NAV total return is a measure of Shareholder value that includes both the current NAV per share and the sum of dividends paid to date. The dividends per share measure shows how much of that Shareholder value has been returned to original investors in the form of dividends. A historical record of these measures is shown in the Financial Highlights.

The Board also considers peer group comparative performance and the Company has continued its membership of the Association of Investment Companies (AIC).

#### Principal risks and uncertainties

The principal risks facing the Company relate to its investment activities and include market price, interest rate and liquidity risk. An explanation of these risks and how they are managed is contained in Note 18 to the Financial Statements.

Additional risks faced by the Company, and the mitigation approach adopted by the Board, are as follows:

- investment objective: the Board's aim is to maximise absolute returns to Shareholders while managing risk by ensuring an appropriate diversification of investments;
- investment policy: inappropriate stock selection leading to underperformance in absolute and relative terms is a risk which the Manager mitigates by operating within investment guidelines and regularly monitoring performance against the peer group. The regulations affecting Venture Capital Trusts are central to the Company's investment policy;
- discount volatility: due to the lack of liquidity in the secondary market, venture capital trust shares tend to trade at discounts to net asset values; and
- regulatory risk: the Company operates in a complex regulatory environment and faces a number of related risks. A breach
  of Section 274 of the Income Tax Act 2007 could result in the Company being subject to capital gains tax on the sale of its
  investments. A breach of the VCT Regulations could result in the loss of VCT status and consequent loss of tax reliefs currently
  available to Shareholders. A serious breach of other regulations, such as the UKLA Listing Rules or the Companies Act, would
  lead to suspension of its shares from the Stock Exchange, loss of VCT status and reputational damage. The Board receives
  quarterly reports from the Manager in order to monitor compliance with regulations.

At least twice each year the Board considers all of the above risks and the measures in place to manage them.

#### **Directors**

Biographies of the Directors who held office at the year end are shown in the Your Board section of the Annual Report along with their interests in the shares of the Company, which are also shown below. No contract or arrangement significant to the Company's business and in which any of the Directors is interested has subsisted during the year.

In accordance with the Articles of Association, Directors must offer themselves for re-election at the first Annual General Meeting following appointment and at least once every three years thereafter. Accordingly, Mr MacMillan and Mrs Wollocombe retire by rotation at the forthcoming Annual General Meeting and, being eligible, offer themselves for re-election.

## Manager and Company Secretary

During the year ended 29 February 2012, investment management, company secretarial, accounting and administration services have been provided to the Company by Maven Capital Partners UK LLP. The management and secretarial fees payable to Maven Capital Partners UK LLP in respect of the year ended 29 February 2012 have been calculated and charged on the following basis:

- (a) a performance related investment management fee calculated as 27.5% of the increase in net asset value of the Company over the six month periods ending 28 February and 31 August in each year, before taking into consideration the effects of distributions and purchases of the Company's own shares made during each period and subject to a minimum amount equivalent to 1.4% per annum of the net asset value of the Company as at the end of February in each year and a maximum amount of £1.25 million in any year; and
- (b) a fixed secretarial fee of £50,000 (2010: £50,000) per annum, which is subject to VAT.

The effects of the investment management and secretarial fees for the year ended 29 February 2012 are detailed in Notes 3 and 4 to the Financial Statements respectively.

The principal terms of the Management and Administration Deed and the separate Co-investment Agreement include:

- the Company will pay to the Manager a performance related management fee calculated as 27.5% of the increase in the net asset value of the Company, over the six-month periods to 28 February and 31 August in each year, before taking into account the effects of distributions and purchases of the Company's own shares effected during that period. The fee is subject to a maximum amount payable of £1.25 million in any year to 28 February and a minimum of 1.4% per annum of the net asset value of the Company. The net asset value from which the fee is measured is rebased to a higher level whenever a performance fee becomes payable;
- in order to ensure that the Manager's staff are appropriately incentivised in relation to the management of the portfolio, a co-investment scheme allows individuals to participate in investment in portfolio companies alongside the Company. All such investments are made through a nominee and under terms previously agreed by the Board. The terms of the scheme ensure that all investments are made on identical terms to those of the Company and that no selection of investments will be allowed. Total investment by participants in the co-investment scheme is set at 5% of the aggregate amount of ordinary shares subscribed for by the Company and the co-investing executives, except where the only securities to be acquired by the Company are ordinary shares or are securities quoted on AIM, in which case the co-investment percentage will be 1.5%. Any dilution of the Company's interests is, therefore, minimal and the Directors believe that the scheme provides a useful incentive which closely aligns the interests of key individuals within the Manager's staff with those of the Shareholders; and

the investment management agreement is terminable, by either party, on the expiry of six months' notice. The appointment may
be terminated without compensation if, inter alia, a receiver, liquidator or administrator of the Manager or the Company is appointed,
or if the Manager or the Company commits a material breach of the relevant Management Agreement (and if such a breach is
capable of remedy and is not remedied within 28 days), or if the Manager ceases to be authorised to carry on investment
business under the Financial Services Act 1986.

In light of investment performance achieved by the Manager, together with the standard of company secretarial and administrative services provided, the Board considers that the continued appointment of the Manager on the stated terms is in the best interests of the Company and its Shareholders.

It should be noted that, as at 31 May 2012, Maven Capital Partners and certain of its executives hold, in aggregate, 702,533 of the Company's Ordinary Shares of 10p each, representing 1.7% of the issued share capital at that date.

## VAT on investment management fees

Following the statement by the Chancellor of the Exchequer in the March 2008 Budget, Her Majesty's Revenue and Customs (HMRC) announced that, from 1 October 2008, all VCTs would be exempt from VAT on management fees and, in addition, VCTs would be able to be able to claim back VAT paid in the previous three years. Following negotiations between HMRC and Aberdeen Asset Management PLC (Aberdeen), the parent company of the former Manager, the Company received an offer from Aberdeen to refund all VAT charged on investment management fees for the period from 1 October 2005 to 31 August 2008. The Board has continued its dialogue with Aberdeen with a view to making further recovery of any amounts due to the Company and has secured a further payment, of £118,425 in respect of VAT paid during the period 28 June 2004 to 30 September 2005, plus interest of £18,585. The Directors have resolved to accept the offer as final settlement on the basis that the Company would remain entitled to any further VAT and interest recovered from HMRC by Aberdeen.

#### **Auditor**

So far as the Directors are aware, there is no relevant audit information (as defined by Section 418 of the Companies Act 2006) of which the Company's Auditor is unaware, and each of the Directors has taken all the steps that he or she ought to have taken as a Director in order to make himself or herself aware of any relevant audit information and to establish that the Company's Auditor is aware of that information.

Resolution 6, to re-appoint Deloitte LLP as Auditor, will be proposed at the forthcoming Annual General Meeting, along with Resolution 7, to authorise the Directors to fix their remuneration.

## Purchase of Ordinary Shares

During the year ended 29 February 2012, the Company bought back 495,000 of its own shares (2011: 211,467), representing 1.29% of the issued share capital at 28 February 2011 (2010: 0.60%), at a weighted average price of 48.65p per share and an aggregate cost, including expenses, of £242,029 (2011: £103,989). These shares have been cancelled and removed from the register.

A Special Resolution, numbered 10 in the Notice of Meeting, will be put to Shareholders at the Annual General Meeting for their approval to renew the Company's authority to purchase in the market a maximum of 6,170,832 Ordinary Shares (representing 14.99% of the shares in issue at 31 May 2012). Such authority will expire on the date of the next Annual General Meeting or after a period of 15 months from the date of the passing of the Resolution, whichever is the earlier. This means, in effect, that the authority will have to be renewed at the Annual General Meeting of the Company to be held in 2013.

Purchases of shares will be made within guidelines established from time to time by the Board, but only if it is considered that such purchases would be to the advantage of the Company and its Shareholders when taken as a whole. Purchases will be made in the market at prices below the prevailing NAV per share. Under the Listing Rules of the UK Listing Authority, the maximum price that may be paid on the exercise of this authority must not exceed 105% of the average of the middle-market quotations for the shares over the five business days immediately preceding the date of purchase. The minimum price that may be paid is 10p per share. In making purchases, the Company will deal only with member firms of the London Stock Exchange. Shares which are purchased will be held in Treasury until either being re-issued or cancelled.

Purchases of shares by the Company will be made from distributable reserves and will normally be paid out of cash balances held by the Company from time to time. As any purchases will be made at a discount to NAV at the time of purchase, the NAV of the remaining Ordinary Shares in issue should increase as a result of any such purchase.

Shares will not be purchased by the Company in the period of 60 days immediately preceding the notification of the Company's Interim Report and the 60 days immediately preceding the announcement of the Annual Report or, if shorter, the period from the end of the Company's relevant financial period up to and including the time of the relevant announcement.

### Issue of new Ordinary Shares

Resolution numbered 8 in the Notice of Meeting will be put to Shareholders at the Annual General Meeting for their approval for the Company to issue up to an aggregate nominal amount of £411,663 (equivalent to 4,116,630 Ordinary Shares or 10% of the total issued share capital at 31 May 2012). Further issues of new Ordinary Shares may only be made at, or at a premium to, NAV per share, thus ensuring existing investors will not be disadvantaged by such issues. The proceeds of any issue may be used to purchase the Company's shares in the market or to fund further investments in accordance with the Company's investment policy. This authority shall expire either at the conclusion of the next Annual General Meeting of the Company or on the expiry of 15 months from the passing of the Resolution, whichever is the first to occur. This means, in effect, that the authority will have to be renewed at the Annual General Meeting of the Company to be held in 2013.

When shares are to be allotted for cash, Section 561(1) of the Companies Act 2006 provides that existing Shareholders have preemption rights and that the new shares are offered first to such Shareholders in proportion to their existing shareholdings. However, Shareholders can, by special resolution, authorise the Directors to allot shares otherwise than by a pro-rata issue to existing Shareholders. Resolution 9 will, if passed, give the Directors power to allot for cash, Ordinary Shares up to an aggregate nominal amount of £411,663 (equivalent to 4,116,630 Ordinary Shares or 10% of the total issued share capital at 31 May 2012) as if Section 561(1) does not apply. This is the same amount of share capital that the Directors are seeking the authority to allot pursuant to Resolution 8. The authority will also expire either at the conclusion of the next Annual General Meeting of the Company or on the expiry of 15 months from the passing of the Resolution, whichever is the first to occur. This means, in effect, that the authority will have to be renewed at the Annual General Meeting of the Company to be held in 2013. The Company will not use this authority in connection with a rights issue.

## Share capital

As at 29 February 2012 the Company's share capital amounted to 39,265,962 Ordinary Shares of 10p each.

Subsequent to the year end, the Company issued a further 1,900,367 shares at an issue price of 65.71p in pursuant to the Offer for Subscription and, as at 31 May 2012, the Company's share capital amounted to 41,166,329 Ordinary Shares of 10p each.

Further details are included in Note 12 to the Financial Statements.

### Principal activity and status

The Company's affairs have been conducted, and will continue to be conducted, in a manner to satisfy the conditions to enable it to continue to obtain approval as a Venture Capital Trust under Section 274 of the Income Tax Act 2007. HM Revenue and Customs will grant Section 274 status, if requested, provided that the Company's affairs have been conducted in such a manner as to satisfy the conditions of that Section of the Act. Such approval was last granted in respect of the year ended 28 February 2011.

#### Corporate governance

The Statement of Corporate Governance is shown on pages 30 to 35.

#### Political and charitable donations

The Company did not make any political or charitable donations during the year ended 29 February 2012 (2011: nil).

### Creditor payment policy

The Company's creditor payment policy is to agree terms of payment before business is transacted, to ensure suppliers are aware of these terms and to settle bills in accordance with them. The Company did not have any material trade creditors at the year end.

#### Financial instruments

The Company's financial instruments comprise its investment portfolio, cash balances and debtors and creditors that arise directly from its operations, including accrued income and purchases and sales awaiting settlement. The main risks that the Company faces arising from its financial instruments are disclosed in Note 18 to the Financial Statements.

#### Going concern

The Company's business activities, together with the factors likely to affect its future development and performance, are set out in this Directors' Report, and the financial position of the Company is described in the Chairman's Statement. In addition, Note 18 to the Financial Statements includes: the Company's objectives, policies and processes for managing its financial risks; details of its financial instruments; and its exposures to market price risk, interest rate risk, liquidity risk and credit risk. The Directors believe that the Company is well placed to manage its business risks.

Having made suitable enquiries, the Directors have a reasonable expectation that the Company has adequate financial resources to enable it to continue in operational existence for the foreseeable future and, accordingly, they have continued to adopt the going concern basis when preparing the Annual Report and Financial Statements.

# **Directors' Remuneration Report**

The Board has prepared this report, in accordance with the requirements of the Companies Act 2006. An Ordinary Resolution for the approval of this report will be put to the Members of the Company at the forthcoming Annual General Meeting. The law requires the Company's Auditor to audit certain of the disclosures provided. Where disclosures have been audited, they are indicated as such. The Auditor's opinion is included in their report on pages 37 and 38.

#### Remuneration Committee

At 29 February 2012, the Company had four non-executive Directors and their biographies are shown in the Your Board section of the Annual Report. The whole Board fulfils the function of a Remuneration Committee, which is chaired by Sir Charles Stuart-Menteth Bt. The names of the Directors who served during the year together with the fees paid during the year are shown in the table on page 29.

During the year ended 29 February 2012, the Board was not provided with advice or services by any person in respect of its consideration of the Directors' remuneration. However, in the application of the Board's policy on Directors' remuneration, as defined below, the Committee expects, from time to time, to review the fees paid to the directors of other venture capital trust companies.

## Policy on Directors' remuneration

The Board's policy is that the remuneration of the Directors, all of whom are non-executive, should reflect the experience of the Board as a whole and be fair and comparable to that of other venture capital trusts with a similar capital structure and similar investment objectives. It is intended that this policy will continue for the year ended 28 February 2013 and subsequent years.

The Company's policy is for the Directors to be remunerated in the form of fees, payable quarterly in arrears, to the Director personally or to a third party specified by him or her. The fees for the Directors are determined within the limits set out in the Company's Articles of Association, which limit the aggregate of the fees payable to the Directors to £100,000 per annum. The Company's policy is that fees payable to the Directors should reflect the time spent by them on the Company's affairs and should be sufficient to enable candidates of a high quality to be recruited and retained. Non-executive Directors do not receive bonuses, pension benefits, share options, long-term incentive schemes or other benefits.

During the year ended 29 February 2012, the Remuneration Committee carried out a review of the remuneration policy and the level of Directors' fees and concluded that no change should be made to the level of Directors' remuneration. It was also agreed that the policy would be to continue to review these rates from time to time.

#### Directors' and Officers' liability insurance

The Company purchases and maintains liability insurance covering the Directors and Officers of the Company. This insurance is not a benefit in kind, nor does it form part of the Directors' remuneration.

#### Directors' service contracts

None of the Directors has a contract of service or contract for services and a Director may resign by giving notice in writing to the Board at any time; there are no set notice periods. All Directors are appointed for an initial period of three years and this period may be varied by mutual consent.


The Articles of Association provide that, at the Annual General Meeting each year, one third of the Directors for the time being (or if their number is not a multiple of three, the number nearest to one third) shall be subject to retirement by rotation. Directors, therefore, shall retire and be subject to re-election at the first Annual General Meeting following their appointment and, thereafter, shall be obliged to retire by rotation, with the option to offer themselves for re-election, at least once every three years.

No compensation is payable for loss of office, save any arrears of fees which may be due.

# Statement of Corporate Governance

The Company is committed to a high standard of corporate governance. The Board has put in place a framework for corporate governance that it believes is appropriate for a venture capital trust and which enables it to comply with the UK Code of Corporate Governance (the Code). The Listing Rules of the UK Listing Authority require the Board to report on compliance with the provisions of the Code and this statement describes how the principles and supporting principles identified in the Code have been applied by the Company during the year ended 29 February 2012, except where disclosed below.

The exceptions to Compliance with the Combined Code, which are explained below, were as follows:

- a senior non-executive Director has not been appointed (Code requirement A4.1) as the Board considers that each of the Directors has different qualities and areas of expertise on which they may lead and, consequently, no individual has unfettered powers of decision; and
- Mr MacMillan and Sir Charles Stuart-Menteth Bt have both served as Directors for a period in excess of the recommended limit
  of nine years (Code provision B.1.1). The Board's view on whether length of service is a factor in determining if a Director may
  continue to serve is set out under "Policy on tenure".

In addition, it should be noted that Mr MacMillan declared an interest as a former non-executive Chairman of Dalglen 1148 Limited, a position which he held until December 2010, a business in which both he and the Company have an investment.

#### The Board

The Board currently consists of four Directors, all of whom are considered to be independent of the investment manager (Maven Capital Partners UK LLP, or the Manager) and free of any relationship which could interfere materially with the exercise of their independent judgement. The biographies of the Directors appear in the Your Board section of this report and indicate their high level and range of investment, industrial, commercial and professional experience.

The Board sets the Company's values and objectives and ensures that its obligations to Shareholders are met. It has formally adopted a schedule of matters which are required to be brought to it for decision, thus ensuring that it maintains full and effective control over appropriate strategic, financial, operational and compliance issues. These matters include:

- the appointment and removal of the Manager and the terms and conditions of any management and administration agreements;
- the maintenance of clear investment objectives and risk management policies;
- the monitoring of the business activities of the Company;
- Companies Act requirements such as the approval of the Interim and Annual Financial Statements and the approval and recommendation of interim and final dividends;
- major changes relating to the Company's structure, including share buy-backs and share issues;
- Board appointments and related matters;
- terms of reference and membership of Board Committees; and
- Stock Exchange, UK Listing Authority and Financial Services Authority matters, such as approval of all circulars, listing particulars and releases concerning matters decided by the Board.

As required by the Companies Act 2006 and permitted by the Articles of Association, Directors notify the Company of any situation which might give rise to the potential for a conflict of interest, so that the Board may consider and, if appropriate, approve such situations. A register of potential conflicts of interest for Directors is reviewed regularly by the Board and the Directors notify the Company whenever there is a change in the nature of a registered conflict, or whenever a new conflict situation arises.

There is an agreed procedure for Directors to take independent professional advice, if necessary, at the Company's expense and the Directors have access to the advice and services of the corporate Company Secretary through its appointed representatives who are responsible to the Board for:

- ensuring that Board procedures are complied with;
- · under the direction of the Chairman, ensuring good information flows within the Board and its Committees; and
- advising on corporate governance matters.

An induction meeting will be arranged by the Manager on the appointment of any new Director, covering details about the Company, the Manager, legal responsibilities and venture capital industry matters. Directors are provided, on a regular basis, with key information on the Company's policies, regulatory and statutory requirements and internal controls. Changes affecting Directors' responsibilities are advised to the Board as they arise.

The Chairman of the Company is a non-executive Director and is Chairman of the Management Engagement and Nomination Committees as the other Directors considers that he has the skills and experience relevant to these roles.

The Board meets at least four times each year and, between Meetings, maintains regular contact with the Manager. The primary focus of quarterly Board Meetings is a review of investment performance and related matters including asset allocation, peer group information and industry issues. During the year ended 29 February 2012, the Board held four quarterly Board Meetings and four Meetings by telephone to discuss specific matters. In addition, there were two Meetings of the Audit Committee and one each of the Management Engagement, Nomination and Remuneration Committees.

Meetings of the Management Engagement, Nomination and Remuneration Committees were held in January 2012 to review, among other things, the performance of the Manager, the appointment and re-election of Directors, the effectiveness of the Board and its Committees and the remuneration policy.

To enable the Board to function effectively and allow Directors to discharge their responsibilities, full and timely access is given to all relevant information. In the case of Board meetings, this consists of a comprehensive set of papers, including the Manager's review and discussion documents regarding specific matters. The Directors make further enquiries when necessary.

The Board and its Committees have undertaken a process for their annual performance evaluation, using questionnaires and discussion to ensure that Directors have devoted a sufficient time and contribute adequately to the work of the Board and its Committees. The Chairman is subject to evaluation by his fellow Directors.

#### Directors' terms of appointment

All non-executive Directors are appointed for an initial term of three years, subject to re-election and Companies Act provisions, and in accordance with the Articles of Association stand for election at the first Annual General Meeting following their appointment. The Articles of Association also state that Directors must offer themselves for re-election at least once every three years.

## Policy on tenure

The Board's policy on tenure is that Directors need not serve on the Board for a limited period of time only. The Board does not consider that the length of service of a Director is as important as the contribution he or she has to make and, therefore, the length of service will be determined on a case by case basis.

#### Committees

Each of the Committees has been established with written terms of reference and comprises the full Board, the members of which are all independent and free from any relationship that would interfere with important judgement in carrying out their responsibilities. The terms of reference of each of the Committees, which are available on request from the Registered Office of the Company, are reviewed and re-assessed for their adequacy at each Meeting.

#### **Audit Committee**

The Audit Committee, chaired by Mr MacMillan, held two Meetings during the year ended 29 February 2012. The Board is satisfied that at least one member of the Committee has recent and relevant financial experience.

The terms of reference of the Audit Committee include:

- the review of the effectiveness of the internal control environment of the Company, including the receipt of reports from internal and external auditors on a regular basis;
- the review of the Interim and Annual Reports and Financial Statements;
- the review of the terms of appointment of the Auditor, together with their remuneration, including any non-audit services provided by the Auditor;
- the review of the scope and results of the audit and the independence and objectivity of the Auditor;
- the review of the Auditor's Board Report and any required response;
- · meetings with representatives of the Manager; and
- making appropriate recommendations to the Board.

At each Meeting, the Audit Committee examined the Annual or Interim Report and Financial Statements, reviewed the Company's internal controls and, when considering the Annual Report, reviewed the scope of the audit and the Auditor's management report to the Board. No significant weaknesses in the control environment were identified.

The Company has in place a policy governing and controlling the provision of non-audit services by the external Auditor, so as to safeguard their independence and objectivity. Shareholders are asked to approve the re-appointment, and the Directors' responsibility for the remuneration, of the Auditor at each Annual General Meeting. Any non-audit work, other than interim reviews, requires the specific approval of the Audit Committee in each case. Non-audit work, where independence may be compromised or conflicts arise, is prohibited and the Audit Committee considers the external Auditor, Deloitte LLP which also provides tax services to the Company, to be independent.

Details of the amounts paid to the Auditor during the year for audit and other services are set out in Note 4 to the Financial Statements.

#### **Management Engagement Committee**

The Management Engagement Committee is chaired by the Chairman of the Company and, on an annual basis, reviews the management contract with the Manager, details of which are shown in the Directors' Report. There was one Meeting held during the year ended 29 February 2012, at which the Committee considered the management contract and recommended the continued appointment of the Manager.

#### **Nomination Committee**

The Chairman of the Company is Chairman of the Nomination Committee and one Meeting was held during the year ended 29 February 2012.

The Committee makes recommendations to the Board on the following matters:

- the evaluation of the performance of the Board and its Committees;
- succession planning; the identification and nomination of candidates to fill Board vacancies, as and when they arise, for the approval of the Board;

- the re-appointment of any non-executive Director at the conclusion of their specified term of office;
- the re-election by Shareholders of any Director under the retirement by rotation provisions in the Company's Articles of Association;
- the continuation in office of any Director at any time; and
- the appointment of any Director to another office, such as Chairman of the Audit Committee, other than to the position of Chairman.

At its Meeting in January 2012, the Nomination Committee recommended to the Board the re-election of Mr MacMillan and Mrs Wollocombe at the Annual General Meeting on the following basis:

- Mr MacMillan has extensive knowledge of corporate finance as well as the operational experience of running a large international engineering business and he also displays a committed and independent approach to the business of the Company; and
- Mrs Wollocombe has a breadth of knowledge of the smaller companies sector and experience in corporate finance, flotations
  and market tactics in takeover bids, and the pricing of secondary issues along with a committed and independent approach to
  the business of the Company.

The Board has endorsed these recommendations and, accordingly, Resolutions 4 and 5 will be put to the Annual General Meeting.

#### Remuneration Committee and Directors' Remuneration

Where a venture capital trust has only non-executive directors, the Code principles relating to directors' remuneration do not apply. However, the Company does have a Remuneration Committee, comprising the full Board and which is chaired by Sir Charles G Stuart-Menteth Bt. The Committee held one Meeting during the year ended 29 February 2012 to review the policy for, and the level of, Directors' Remuneration. The level of remuneration for the Directors has been set in order to attract and retain individuals of a calibre appropriate to the future development of the Company. The Company's policy on Directors' Remuneration, together with details of the remuneration of each Director, is detailed in the Directors' Remuneration Report.

#### Internal control

The Board of Directors of Maven Income and Growth VCT PLC has overall responsibility for the Company's system of internal control and for reviewing its effectiveness. As the Directors have delegated the investment management, company secretarial and administrative functions of the Company to the Manager, the Board considers that it is appropriate for the Company's internal controls to be monitored by the Manager, rather than by the Company itself. The Directors confirm that there is an ongoing process for identifying, evaluating and managing the significant risks faced by the Company, which has been in place for the full year under review and up to the date of approval of the Annual Report and Financial Statements. This process is regularly reviewed by the Board and accords with the guidance for directors on internal control: "Internal Control: Guidance for Directors on the Combined Code" (the Turnbull Guidance).

The Board has reviewed the effectiveness of the system of internal control and, in particular, it has reviewed the process for identifying and evaluating the significant risks affecting the Company and the policies and procedures by which these risks are managed. The Directors have delegated the management of the Company's assets to the Manager and this embraces implementation of the system of internal control, including financial, operational and compliance controls and risk management.

Internal control systems are monitored and supported by the compliance function of the Manager, which undertakes periodic examination of business processes, including compliance with the terms of the Management and Administration Deed, and ensures that recommendations to improve controls are implemented.

Risks are identified through a risk management framework by each function within the Manager's activities. Risk is considered in the context of the Turnbull Guidance and includes financial, regulatory, market, operational and reputational risk. This helps the internal audit risk model identify those functions most appropriate for review. Any errors or weaknesses identified are reported to the Company and timetables are agreed for implementing improvements to systems. The implementation of any remedial action required is monitored and feedback provided to the Board.

The key components designed to provide effective internal control for the year under review and up to the date of this report are:

- the Manager prepares forecasts and management accounts which allow the Board to assess the Company's activities and review its investment performance;
- the Board and Manager have agreed clearly defined investment criteria, specified levels of authority and exposure limits. Reports
  on these issues, including performance statistics and investment valuations, are submitted regularly to the Board;
- the Manager's evaluation procedure and financial analysis of the companies concerned include detailed appraisal and due diligence;
- the compliance team of the Manager continually review the Manager's operations;
- written agreements are in place which specifically define the roles and responsibilities of the Manager and other third party service providers;
- clearly documented contractual arrangements exist in respect of any activities that have been delegated to external professional organisations;
- the Board carries out a six-monthly assessment of internal controls by considering reports from the Manager's compliance function and taking account of events since the relevant period end; and
- the compliance function of the Manager reports annually to the Audit Committee and has direct access to the Directors at any time.

The internal control systems are intended to meet the Company's particular needs and the risks to which it is exposed. Accordingly, these systems are designed to manage, rather than eliminate, the risk of failure to achieve business goals and, by their nature, can provide reasonable, but not absolute, assurance against material misstatement of loss.

#### External agencies

The Board has contractually delegated to external agencies, including the Manager, certain services: the management of the investment portfolio, the custodial services (which include the safeguarding of assets), the registration services and the day to day accounting and company secretarial requirements. Each of these contracts was entered into after full and proper consideration by the Board of the quality and cost of services offered. The Board receives and considers reports from the Manager and other external agencies on a regular basis. In addition, ad hoc reports and information are supplied to the Board as requested.

#### Accountability and audit

The Statement of Directors' Responsibilities in Relation to the Financial Statements is on page 36 and a statement of going concern is included in the Directors' Report on page 27. The Independent Auditor's Report is on pages 37 and 38 and it should be noted that the Auditor, Deloitte LLP, rotates the partner responsible for the Company's audit every five years.

#### Exercise of voting powers

The Directors believe that the exercise of voting rights lies at the heart of regulation and the promotion of good corporate governance and, therefore, the Board has given discretionary powers to the Manager to vote in respect of the holdings in the Company's investment portfolio.

## Socially responsible investment policy

The Directors and the Manager are aware of their duty to act in the interests of the Company. They acknowledge that there are risks associated with investment in companies which fail to conduct business in a socially responsible manner and the Directors, therefore, ensure that the Manager takes regular account of the social environment and ethical factors that may affect the performance or value of the Company's investments.

#### Communication with Shareholders

The Company places a great deal of importance on communication with its Shareholders. The Annual General Meeting is an event that all Shareholders are welcome to attend and participate in. The Notice of Meeting sets out the business of the Annual General Meeting and the Resolutions are explained more fully in the Directors' Report and in the Directors' Remuneration Report. Separate Resolutions are proposed for each substantive issue and Shareholders have the opportunity to put questions to the Board and to the Manager. The results of proxy voting are relayed to Shareholders after each Resolution has been voted on by a show of hands. Nominated persons, often the beneficial owners of shares held for them by nominee companies, may attend Shareholder Meetings and are invited to contact the registered Shareholder, normally a nominee company, in the first instance in order to be nominated to attend the Meeting and to vote in respect of the shares held for them. It is in the nature of a venture capital trust that it generally has few major shareholders.

As required under the Code, the Annual Report is normally posted to Shareholders at least twenty business days before the Annual General Meeting. Annual and Interim Reports and Financial Statements are distributed to Shareholders and other parties who have an interest in the Company's performance. Shareholders and potential investors may obtain up-to-date information on the Company through the Manager and the Secretary, and the Company responds to letters from Shareholders on a wide range of issues. In order to ensure that the Directors develop an understanding of the views of Shareholders, correspondence between Shareholders and the Manager or the Chairman is copied to the Board. The Company's web pages are hosted on the Manager's website, and can be visited at www.mavencp.com/migvct from where Annual and Interim Reports, Stock Exchange Announcements and other information can be viewed, printed or downloaded. Access to further information about the Manager can be gained from www.mavencp.com.

## Notes to the Financial Statements

## For the year ended 29 February 2012

#### 1 Accounting Policies - UK Generally Accepted Accounting Practice

#### (a) Basis of preparation

The Financial Statements have been prepared under the historical cost convention, modified to include the revaluation of investments, and in accordance with the Statement of Recommended Practice 'Financial Statements of Investment Trust Companies and Venture Capital Trusts' (the SORP) issued in January 2009.

The disclosures on Going Concern in the Directors' Report on page 27 form part of these Financial Statements.

#### (b) Income

Dividends receivable on equity shares and unit trusts are treated as revenue for the period on an ex-dividend basis. Where no ex-dividend date is available dividends receivable on or before the year end are treated as revenue for the period. Provision is made for any dividends not expected to be received. The fixed returns on debt securities and non-equity shares are recognised on a time apportionment basis so as to reflect the effective interest rate on the debt securities and shares. Provision is made for any fixed income not expected to be received. Interest receivable from cash and short term deposits and interest payable are accrued to the end of the year.

#### (c) Expenses

All expenses are accounted for on an accruals basis and charged to the income statement. Expenses are charged through the revenue account except as follows:

- expenses which are incidental to the acquisition and disposal of an investment are charged to capital; and
- expenses are charged to realised capital reserves where a connection with the maintenance or enhancement of the value
  of the investments can be demonstrated. In this respect the investment management fee has been allocated 20% to
  revenue and 80% to realised capital reserves to reflect the Company's investment policy and prospective income and
  capital growth.

### (d) Taxation

Deferred taxation is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date, where transactions or events that result in an obligation to pay more tax in the future or right to pay less tax in the future have occurred at the balance sheet date. This is subject to deferred tax assets only being recognised if it is considered more likely than not that there will be suitable profits from which the future reversal of the underlying timing differences can be deducted. Timing differences are differences arising between the Company's taxable profits and its results as stated in the Financial Statements which are capable of reversal in one or more subsequent periods.

Deferred tax is measured on a non-discounted basis at the tax rates that are expected to apply in the periods in which timing differences are expected to reverse, based on tax rates and laws enacted, or substantively enacted, at the balance sheet date.

The tax effect of different items of income/gain and expenditure/loss is allocated between capital reserves and revenue account on the same basis as the particular item to which it relates using the Company's effective rate of tax for the period.

UK Corporation tax is provided at amounts expected to be paid/recovered using the tax rates and laws that have been enacted, or substantively enacted, at the balance sheet date.

### (e) Investments

In valuing unlisted investments the Directors follow the criteria set out below. These procedures comply with the revised International Private Equity and Venture Capital Valuation Guidelines (IPEVCV) for the valuation of private equity and venture capital investments. Investments are recognised at their trade date and are designated by the Directors as fair value through profit and loss. At subsequent reporting dates, investments are valued at fair value, which represents the Directors' view of the amount for which an asset could be exchanged between knowledgeable and willing parties in an arm's length transaction. This does not assume that the underlying business is saleable at the reporting date or that its current shareholders have an intention to sell their holding in the near future.

A financial asset or liability is generally derecognised when the contract that gives rise to it is settled, sold, cancelled or expires.

- For investments completed within the 12 months prior to the reporting date, and those at an early stage in their development, fair value is determined using the Price of Recent Investment Method except that adjustments are made when there has been a material change in the trading circumstances of the company or a substantial movement in the relevant sector of the stock market.
- 2. Whenever practical, recent investments will be valued by reference to a material arm's length transaction or a quoted price.
- 3. Mature companies are valued by applying a multiple to their fully taxed prospective earnings to determine the enterprise value of the company.
  - 3.1 To obtain a valuation of the total ordinary share capital held by management and the institutional investors, the value of third party debt, institutional loan stock, debentures and preference share capital is deducted from the enterprise value. The effect of any performance related mechanisms is taken into account when determining the value of the ordinary share capital.
  - 3.2 Preference shares, debentures and loan stock are valued using the Price of Recent Investment Method. When a redemption premium has accrued, this will only be valued if there is a reasonable prospect of it being paid. Preference shares which carry a right to convert into ordinary share capital are valued at the higher of the Price of Recent Investment Method basis and the price/earnings basis, both described above.
- 4. Where there is evidence of impairment, a provision may be taken against the previous valuation of the investment.
- 5. In the absence of evidence of a deterioration, or strong defensible evidence of an increase in value, the fair value is determined to be that reported at the previous balance sheet date.
- 6. All unlisted investments are valued individually by the portfolio management team of Maven Capital Partners UK LLP. The resultant valuations are subject to detailed scrutiny and approval by the Directors of the Company.
- 7. In accordance with normal market practice, investments listed on the Alternative Investment Market or a recognised stock exchange are valued at their bid market price.

#### (f) Fair value measurement

Fair value is defined as the price that the Company would receive upon selling an investment in a timely transaction to an independent buyer in the principal or the most advantageous market for the investment. A three-tier hierarchy has been established to maximise the use of observable market data and minimise the use of unobservable inputs and to establish classification of fair value measurements for disclosure purposes. Inputs refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk, for example, the risk inherent in a particular valuation technique used to measure fair value including such a pricing model and/or the risk inherent in the inputs to the valuation technique. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the reporting entity.

Unobservable inputs are inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on best information available in the circumstances

The three-tier hierarchy of inputs is summarised in the three broad levels listed below:

- Level 1 quoted prices in active markets for identical investments;
- Level 2 other significant observable inputs (included quoted prices for similar investments, interest rates, prepayment speeds, credit risk etc); and
- Level 3 significant unobservable inputs (including the Company's own assumptions in determining the fair value of investments).

#### (g) Gains and losses on investments

When the Company sells or revalues its investments during the year, any gains or losses arising are credited/charged to the Income Statement.

The Company's financial instruments comprise equity and fixed interest investments, cash balances and debtors and creditors that arise directly from its operations, for example, in respect of sales and purchases awaiting settlement, and debtors for accrued income. The Company holds financial assets in accordance with its investment policy of investing mainly in a portfolio of VCT qualifying unquoted and quoted securities. The Company may not enter into derivative transactions in the form of forward foreign currency contracts, futures and options without the written permission of the Directors. No derivative transactions were entered into during the period.

The main risks the Company faces from its financial instruments are: (i) market price risk, being the risk that the value of investment holdings will fluctuate as a result of changes in market prices caused by factors other than interest rate or currency movement; (ii) interest rate risk; and (iii) liquidity risk. In line with the Company's investment objective, the portfolio comprises UK securities and, therefore, has no exposure to foreign currency risk.

The Manager's policies for managing these risks are summarised below and have been applied throughout the year. The numerical disclosures below exclude short-term debtors and creditors which are included in the Balance Sheet at fair value.

#### (i) Market price risk

The Company's investment portfolio is exposed to market price fluctuations, which are monitored by the Manager in pursuance of the investment objective as set out on page 22. Adherence to investment guidelines and to investment and borrowing powers set out in the Management Agreement mitigates the risk of excessive exposure to any particular type of security or issuer and, in particular, no purchase can be made in any one company where this would result in a holding that would exceed 7.5% of the Company's investments at the time the investment is made.

These powers and guidelines include the requirement to invest in a number of companies across a range of industrial and service sectors at varying stages of development but with the emphasis on well established businesses. The Company complied with the stated investment guidelines and borrowing powers throughout the year ended 29 February 2012.

Further information on the investment portfolio (including sector analysis, concentration and deal type analysis) is set out in the Analysis of Unlisted and AIM/PLUS Portfolio, the Investment Manager's Review, the Summary of Investment Changes, the Investment Portfolio Summary and the Largest Unlisted and AIM/PLUS Investments.

Credit risk arising on fixed interest instruments is mitigated by investing in UK Government Stock.

All fixed interest assets which are traded on a recognised exchange are held by JP Morgan Chase (JPM), the Company's custodian. Cash balances are held by JPM, RBS and Clydesdale. The notes on the following pages given an explanation of the proposed Resolutions.

Resolutions 1 to 8 are proposed as Ordinary Resolutions. For each of those Resolutions to be passed, more than half of the votes cast must be in favour of the Resolution. Resolutions 9 to 11 are proposed as Special Resolutions. This means that for each of those Resolutions to be passed, at least three-quarters of the votes cast must be in favour of the Resolution.

#### Resolution 1 - Annual Report and Financial Statements

The Directors of the Company must present to the Meeting the audited annual accounts and the Directors' and Auditor's reports for the financial year ended 29 February 2012.

#### Resolution 2 - Directors' Remuneration Report

The Company's Shareholders will be asked to approve the Directors' Remuneration Report contained in the Annual Report and Accounts at the Annual General Meeting.

#### Resolution 3 - Final dividend

The Company's Shareholders will be asked to approve the payment of a final dividend.

Under Resolution 10, the Company's Shareholders are being asked to renew the Directors' authority to make market purchases of up to 6,170,832 Ordinary Shares of the Company (which represents approximately 14.99 per cent of the issued share capital of the Company at 31 May 2012) and the Resolution sets out the minimum and maximum prices that can be paid, exclusive of expenses. The minimum price is equal to the nominal value of an Ordinary Share from time to time and maximum price is equal to the higher of:

- (i) 105 per cent of the average of the closing middle market price of an Ordinary Share of the Company for the five business days prior to the date of purchase; and

#### Resolution 11 - Notice of General Meetings

This Resolution is required to reflect the implementation in August 2009 of the Shareholder Rights Directive. The regulation implementing this Directive increased the notice period for General Meetings of the Company to 21 days. The Company is currently able to call General Meetings (other than an AGM) on 14 clear days' notice and would like to preserve this ability. In order to be able to do so, Shareholders must have approved the calling of General Meetings on 14 days' notice. Resolution 11 seeks such approval.

The approval will be effective until the Company's next Annual General Meeting, when it is intended that a similar Resolution will be proposed. The Company will also need to meet the requirements for electronic voting under the Directive before it can call a General Meeting on 14 days' notice.

## Company profile

Maven Income and Growth VCT PLC (formerly known as Aberdeen Income and Growth VCT PLC and Murray VCT 4 PLC) is a venture capital trust (VCT) and a constituent of the FTSE All-Share Index. It has one class of share and was incorporated on 12 January 2000.

### Investment objective

The Company aims to achieve long term capital appreciation and generate maintainable levels of income for Shareholders.

#### Benchmark

There is no meaningful venture capital trust index against which to compare the performance of the Company. However, for reporting to the Board and Shareholders, the Manager uses comparisons with appropriate indices and the Company's peer group.

#### Capital structure

The Company's issued share capital as at 29 February 2012 consisted of 39,265,962 Ordinary Shares of 10p each.

## Total assets and NAV per share

At 29 February 2012, the Company had net assets of £26,662,000 and an NAV per share of 67.9p.
